During his years of service in local and state government, he has remained true to the folks he has served. Surely, you will agree that Scott Angelle loves the great state of Louisiana and its people.

Through his remarkable career that started at age 25, Scott has been a champion for making government work smarter. Breaking the mold; Scott reduced his own public salary, he earned a reputation for being a good steward of taxpayer funds, and brought competence and creativity in communicating and negotiating complex issues. His work ethic is well known. He leads by example, often arriving early and leaving late. No one out-works or out-prepares Scott.

He has served as our Secretary of the Department of Natural Resources, being the only person in that role to serve two governors of different parties. He was unanimously confirmed by the Louisiana Legislature to serve as our Interim Lieutenant Governor in 2010. Scott was the State's point man in efforts to lift the Gulf of Mexico drilling moratorium and get offshore drilling reinstated. He immediately mobilized, organized, and testified before Congress. Today, the US has more rigs working in the Gulf than we had at the time of the Deepwater Horizon event. When we gathered as a state at the Cajundome, Scott sent a powerful message from the banks of the Vermilion River to the banks of the Potomac River that not on our watch would this generation allow an entire industry to be shut down with the stroke of a pen.
