But for the last minute heads up, I would have been completely caught off guard by the reporter last week who wanted to know if I was being forced or pressured to step down from the Commission. As you may have read, I responded by stating that "I am stepping down of my on volition."

Now that I am fully aware of the prohibition, I feel that I must step down as a Commission Member so I will not feel constrained in my desire to help persons who I would like to support politically. I ran for elective office twice and would not have been successful but the campaign contributions I received from my friends and supporters.

Like all of us who serve on the Commission, it was a fulfillment of my civic responsibility. At no time during my service was I presented with an issue where I was conflicted because a contribution I may have made. And had one presented itself I surely would have recused myself.

After reading Franklin Kyle's letter, I felt a need to go the record to be responsive. When first asked to go on the Louisiana State Police Commission by Governor Jindal I hesitated, in that over many decades I had been asked by many governors to serve on various boards and commissions, all of which I had turned down (i.e. Louisiana Board of Regents). Only because of my keen interest and involvement and support of law enforcement for the past 30 years, did I accept. Upon joining the commission there was absolutely no orientation or rules that were given to me. Approximately 3 years ago, there was a vacancy on the commission and I was asked who might be a suitable candidate to fill the spot. I suggested a prominent businessman, Boysie Bollinger who was accepted and sworn in. Within 24 hours he resigned when his attorney informed him of a ruling forbidding anyone on the commission to make political contributions or be involved in a political campaign. Mr. Bollinger personally called me to make me aware of the ruling which I was never informed. I then called and wrote to the governors office to get a full explanation of the responsibilities of commission members, which were never given to me. Since then I have been solicited personally (orally and by mail) by hundreds of people who I have continually turned down as well as sent them a copy of my enclosed correspondence. MARRIAGE CONTRACT

UNITED STATES OF AMERICA

BETWEEN: MELISSA M. NAQUIN

STATE OF LOUISIANA

AND:

FRANKLIN M. KYLE, III

PARISH OF ST. TAMMANY

ON THE RESPECTIVE DATES before the undersigned authorities, duly commissioned and qualified in and for the State of Louisiana, respective parishes, and in the presence of the subscribing witnesses, PERSONALLY CAME AND APPEARED:

MELISSA M. NAQUIN, a person of the full age of majority and domiciled in St. Tammany Parish, Louisiana, whose mailing address is 342 Rosedown Way, Mandeville, Louisiana 70471,

and

FRANKLIN M. KYLE, III, a person of the full age of majority and domiciled in St. Tammany Parish, Louisiana, whose mailing address is 131 Seven Pines Blvd., Mandeville, Louisiana 70471,

who severally declared that they do plan and intend to be joined in the bonds of matrimony on or about the 14th day of February, 2004, and thereafter intend to reside in St. Tammany Parish, State of Louisiana, and in order to fix certain rights between them, they do contract as follows to establish the matrimonial regime under which they shall live.

Τ.

The intended husband and wife shall be totally separate in property including but not limited to earnings, wages, annuities, pension plans, and royalties; dividends, stock dividends, stocks; stock options, stock appreciation rights; U.S. Savings bonds and/or bond appreciation, interest, CD's, IRA's, ESOP plans, 401(K) investments, mutual funds, promissory notes, and interest thereon and retirements plans and rents. Neither of them shall be personally liable for the debts contracted by the other or for either party's quasi or intentional offenses, either before or during the marriage. Accordingly, they hereby formally renounce all those provisions of the Revised Civil Code which establishes a community of acquets and gains between husband and wife.

II.

The parties hereto recognize and acknowledge that each of them is the owner of separate property; that each desires the separate properties to so remain, including any property acquired after marriage by either of them, and each reserves to himself or herself, as the case may be, individually the entire administration and control of such property for his

or her sole separate use and benefit. MELISSA M. NAQUIN'S separate property is listed on Exhibit "A", attached hereto and made a part hereof, and FRANKLIN M. KYLE, III's separate property is listed on Exhibit "B" attached hereto and made a part hereof. For purposes of disclosure, the parties have reviewed and initialed both Exhibits "A" and "B", and each acknowledges that they are satisfied with the disclosure but specifically request that Exhibits "A" and "B" not be made a part of the public record.

III.

MELISSA M. NAQUIN reserves to herself all fruits and revenues of all of her separate property, whether itemized or not, whether such fruits be natural or civil, including, but not limited to interest, dividends and rents, and the reinvestment and continued reinvestment of the separate property and including any enhancement to the property, for her own separate use and benefit and for her sole administration and control. Fruits and revenues, including without limitation, salaries, and all other benefits resulting from pension and profit sharing benefits, and all other benefits resulting from MELISSA M. NAQUIN'S labors before and during the marriage shall be and remain her separate property. FRANKLIN M. KYLE, III waives and relinquishes any right which he might have in the future for claims and/or improvements to MELISSA M. NAQUIN'S separate property, which claims and/or improvements result from the common labor or property of them both or otherwise.

IV.

FRANKLIN M. KYLE, III reserves to himself all fruits and revenues of all of his separate property, whether itemized or not, whether such fruits be natural or civil, including, but not limited to interest, dividends and rents, and the reinvestment and continued reinvestment of the separate property and including any enhancement to the property, for his own separate use and benefit and for his sole administration and control. Fruits and revenues, including without limitation, salaries, and all other benefits resulting from pension and profit sharing benefits, and all other benefits resulting from FRANKLIN M. KYLE, III's labors before and during the marriage shall be and remain his separate property. MELISSA M. NAQUIN waives and relinquishes any right which she might have in the future for claims and/or improvements to FRANKLIN M. KYLE, III's separate property, which claims and/or improvements result from the common labor or property of them both or otherwise.

Each party has made such inquiry into the property and debts of the other as he or she thinks is appropriate, and hereby releases the other, his or her heirs, successors and assigns from any rights or claims they might have, reserve, or hereafter acquire as a result of any further investigation.

VI.

All property and effects of the said husband and wife, which each party now own, whether owned by him or her at the time of the celebration of said intended marriage, or acquired during said marriage, whether acquired by gift, devise, inheritance, conveyance, transfer or earnings or by any other means whatsoever, together with the rents, issues, fruits, interest, earnings, profits, dividends, increases in value or other enhancements emanating therefrom shall be and continue to be the sole and/or separate non-marital property of such party and they do hereby declare all of the above to be separate property. The parties herein, the intended husband and wife, do hereby expressly reserve to themselves individually, the entire administration of their respective particular movables and immovable property, and the respective free enjoyment of each of their revenues.

VII.

All natural and civil fruits and revenues of the separate property of each intended spouse, as well as minerals produced from or attributable to a separate asset, and bonuses, delay rentals, royalties, and shut in payments arising from mineral leases are declared to be and are reserved as the separate property of the intended spouse who owns the thing.

VIII.

All damages, insurance, or indemnity collected due to personal injury, property damage, or other cause are separate property of the spouse who sustained the injury or damage, whether before or during the marriage.

IX.

Both parties herein have been married before. Each has children by former marriages.

X.

Each party may be or become legally obligated to support their children of prior marriages. If so, each agrees to support his or her children out of his own estate, hereby waiving and renouncing on behalf of himself, his children and any other party at interest, the right to claim such support from the other, or from the property or estate of the other.

An alimentary obligation imposed by law on a spouse shall be a separate obligation of that spouse.

#### XII.

An increase during the marriage in the value of the separate property of a spouse inures to the benefit of that spouse, whether the increase is due to the uncompensated labor or industry of the spouses or not. Buildings, other constructions permanently attached to the ground, component parts, and plantings made on the land of one spouse belong to the owner of the ground. Upon termination of the marriage of the spouse whose assets were used to improve the separate property of the other spouse is not entitled to any reimbursement unless otherwise agreed in writing by both spouses.

#### XTTT.

The term "property" as used herein shall mean all property whether real, personal or mixed, movable or immovable, tangible or intangible, of whatsoever kind or wheresoever situated and however acquired, whether now owned by either party or hereafter acquired.

#### XIV.

That property which is specifically registered, deeded and/or titled in both parties' names in a form of joint ownership shall not be considered community property, but shall be regarded as separate property in the form of joint ownership.

#### XV.

The sole, separate and/or non-marital property of each party shall not be subject to community property, equitable distribution or similar or like laws of any jurisdiction which creates or provides rights for one spouse in the property of the other spouse; providing however, that right(s) accruing by virtue of a spouse's demise shall not be affected by this Marriage Contract.

#### XVI.

No partnership shall exist between the parties except as to property which comes within the scope referred to in Paragraph XIV hereof.

#### XVII.

The intended husband and wife shall be separate in property, wherefore, neither of them shall be liable for the debts contracted by the other, or for

either party's quasi or intentional offenses, either before or during their marriage, and the intended husband and wife shall have the free and exclusive enjoyment of their separate property and the sole and full administration thereof, including the right to act alone in the acquisition of any additional property, management, alienation, encumbrance, or disposal of his or her separate property without the consent or concurrence of the other spouse.

XVIII.

Except as provided in Articles XXII and XXIII below, it is the specific intention of each party to this agreement that neither party to this agreement or any other party under a theory of law shall have an economic claim on the other spouse as a result of the marriage of the spouses and/or as a result of the termination of this marriage.

XIX.

Each party agrees that all deferred compensation benefits including individual retirement accounts, are and shall belong exclusively to the spouse who earned them, whether earned in whole or in part, before or during the marriage. Each party hereby consents to and waives any and all rights to spousal benefits to which they might otherwise be entitled under the Retirement Equity Act of 1984 or similar or subsequent federal or state statutes. Each agrees to sign such additional documents as may be required by the Internal Revenue Service, the plan administrator or other party to carry out this intention.

XX.

At any time and from time to time, after the celebration of the marriage and without consideration, each of the parties agrees to execute any documents that may reasonably be required to confirm in the other spouse, his separate property or to enable him to administer, control, enjoy, dispose of, manage, alienate, encumber or leave his separate property.

XXI.

The parties declare that the sharing of expenses of the marriage shall not in any way be deemed to create any rights of reimbursement between the spouses, nor shall the sharing of such expenses create any property right whatsoever in the property of the other spouse or any claim against the property of the other spouse.

The parties desire to provide for the rights and obligations of each in the event of dissolution of the marriage especially as to any alimony rights of MELISSA M. NAQUIN and to prevent any litigation between them respecting alimony rights, other support rights, property or income rights, reimbursement issues, etc. the parties hereby declare that if there is a dissolution of the marriage other than by death, FRANKLIN M. KYLE, III will pay MELISSA M. NAQUIN the sum of ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00)

DOLLARS payable and due in monthly installments of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS per month, with the first payment being effective on the first day of each month following the filing for divorce by either party, said monthly payment shall apply toward the \$150,000.00 amount of alimony referred to hereinabove, with the further understanding that when the judgment of divorce is signed by the judge that the balance of the \$150,000.00 payment referred to hereinabove is immediately due and payable by FRANKLIN M. KYLE, III to MELISSA M. NAQUIN.

#### XXIII.

Additionally, the parties desire to provide certain rights and obligations in the event the marriage is dissolved by death as follows:

- a) In the event that MELISSA M. NAQUIN should predecease FRANKLIN M. KYLE, III, then in that event, her descendants by roots in being at her death or any trust established by her in their behalf, shall receive One Hundred Fifty Thousand and no/100 (\$150,000.00) Dollars in cash from FRANKLIN M. KYLE, III personally, or from life insurance funded by him. If this obligation is not covered by life insurance, FRANKLIN M. KYLE, III shall fund this obligation within ninety (90) days after her death.
- b) In the event that FRANKLIN M. KYLE, III should predecease MELISSA M. NAQUIN, then in that event, MELISSA M. NAQUIN shall receive One Hundred Fifty Thousand and no/100 (\$150,000.00) Dollars in cash from FRANKLIN M. KYLE, III by either a life insurance policy funded by him, or as a particular legatee in his last will and testament, or as a priority debt due by his estate.

#### xxiv.

All property or liabilities in which either party receives as an inheritance from any source, will not be considered community property, but will be considered the sole property/obligation of the individual inheriting.

#### XXV.

The parties agree that they have been advised by their attorneys of their rights with regard to a Marriage Contract, and acknowledge that they are entering into this agreement freely and voluntarily; that they have ascertained and weighed all of the facts and circumstances likely to influence their judgment herein; that they have been duly appraised of their respective legal rights with respect to a Marriage Contract; that all of the provisions of this agreement, as well as all questions pertinent thereto have been fully and satisfactorily explained to them by their respective attorneys'; that they have been given due consideration to such provisions and questions; and that they understand clearly and assent to all of the provisions of this agreement. The parties further acknowledge that they have had the opportunity to make changes in this document.

#### XXVI.

If any of the provisions of this Marriage Contract shall be invalid, such invalidity shall not affect other provisions that can be given effect without the invalid provisions and to this end the parties hereby declare that the provisions of this Marriage Contract are severable.

#### XXVII.

This Marriage Contract shall be governed by the law of Louisiana. It is intended to continue to be applicable notwithstanding that the party(ies) may live or be domiciled in another jurisdiction, and shall be binding on the parties hereto, their heirs, executors, administrators and assigns.


