

RESOLUTION NO. 10-481

On motion by Council Member Friedman, seconded by Council Member Turner, and on roll call all members present voting “Yes”, except Council Members Guey and Buras, voting “No”, and Council Members Hinkley and Cooper, absent, the following resolution was adopted.

A Resolution authorizing and directing the Parish President to provide to the Council any and all documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, interoffice documentation, and intra-office documentation generated by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present; authorizing and directing the Parish President to provide to the Council any and all documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, interoffice documentation and intra-office documentation received by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present; authorizing and directing the Parish President to provide to the Council any documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, inter office documentation and intra office documentation signed and/or initialed by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present; authorizing and directing the Parish President to provide to the Council any and all timesheets and payroll records of Stephen Braud from January 1, 2010, to the present; authorizing and directing the Parish President to provide to the Council any and all checks, including but not limited to, payroll and reimbursements issued to Stephen Braud since January 1, 2010; authorizing and directing the Parish President to provide to the Council any proof of payment issued to any person, firm, corporation, limited liability company or any other legal entity for wages, salary, reimbursements or payments for services in any way related to Stephen Braud; authorizing and directing the Parish Council Legal Department and/or its designee to file a Petition for Writ of Mandamus against the Parish President, William H. Nungesser to compel him to produce the above requested documents should the documents not be provided within the delays allowed by law; and otherwise to provide with respect thereto.

WHEREAS, a public records request was submitted to the Plaquemines Parish Legal Department, Assistant Attorney Mike Mullin on August 3, 2010, via certified mail requesting said documents; and

WHEREAS, as of this date the documents have not been received by the Council; and

WHEREAS, it is the expressed intent of the Parish Council to style this resolution as a Request for Public Records; and

NOW, THEREFORE:

BE IT RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide to the Council any and all documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, interoffice documentation, and intra-office documentation generated by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide the Council any and all documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, interoffice documentation and intra-office documentation received by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide to the Council and documents, pleadings, emails, facsimiles, correspondence, letters, memorandums, inter office documentation and intra office documentation signed and/or initialed by Stephen Braud as an attorney for the Parish of Plaquemines from January 1, 2010, to the present.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide to the Council any and all time sheets and payroll records of Stephen Braud from January 1, 2010, to the present.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide to the Council any and all checks, including but not limited to payroll and reimbursements, issued to Stephen Braud since January 1, 2010 to the present.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President to provide to the Council any and all proof of payment issued to any person, firm, corporation, limited liability company or any other legal entity for wages, salary, reimbursements or payments for services in any way related to Stephen Braud.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that should the requested documents not be provided within the delays allowed by law, the Council Legal Department and/or its designee is authorized and directed to file a Petition for Writ of Mandamus against the Parish President, William H. Nungesser to compel him to produce the above requested documents.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that the Secretary of this Council is hereby authorized and directed to immediately certify and release this Resolution and that Parish employees and officials are authorized to carry out the purposes of this Resolution, both without further reading and approval by the Plaquemines Parish Council.
