

RESOLUTION NO. 10-512

On motion by Council Member Turner, seconded by Council Member Beshel, and on roll call all members present voting "Yes", except Council Members Hinkley, absent, and Guey voting "No", the following Resolution was adopted.

A Resolution authorizing and directing the Parish President, in accordance with the Public Records Law, to provide the Parish Council any and all Project Worksheets, Contracts, Agreements, Memoranda of Understanding, etc. relative to FEMA funding executed by President Nungesser from January 1, 2007, to date; and authorizing and directing the Council Legal Department and/or its designee to file a Petition for Writ of Mandamus against William H. Nungesser compelling him to furnish the Council any and all Project Worksheets, Contracts, Agreements, Memoranda of Understanding, etc. relative to FEMA funding executed by President Nungesser from January 1, 2007, to date should the requested documents not be provided to the Council within the time delays allowed by law; and otherwise to provide with respect thereto.

WHEREAS, the Plaquemines Parish Council seeks information and documents pertaining all FEMA funding;

NOW, THEREFORE:

BE IT RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Parish President, in accordance with the Public Records Law, to provide the Parish Council a copy of any and all Project Worksheets, Contracts, Agreements, Memoranda of Understanding, etc. relative to FEMA funding executed by President Nungesser from January 1, 2007, to date.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council it is the intention of the Parish Council to style this Resolution as a Request for Public Records from the Parish President.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that it hereby authorizes and directs the Council Legal Department and/or its designee to file a Petition for Writ of Mandamus against William H. Nungesser compelling him to provide to the Parish Council any and all Project Worksheets, Contracts, Agreements, Memoranda of Understanding, etc. relative to FEMA funding executed by President Nungesser from January 1, 2007, to date should the requested documents not be provided to the Council within the time delays allowed by law.

BE IT FURTHER RESOLVED by the Plaquemines Parish Council that the Secretary of this Council is hereby authorized and directed to immediately certify and release this Resolution and that the Parish employees and officials are authorized to carry out the purposes of this Resolution, both without further reading and approval by the Plaquemines Parish Council.
