On Monday, April 02, 2007 at approximately 12:07 p.m., Deputy Michael Wintzel responded to Lady of the Sea hospital in Galliano in reference to meeting with Jimmy Blankenship (w/m dob: 6-04-81) who stated that he was living in room number 29 at P.J.'s Ped Pond and he believed that someone violated him sexually. Jimmy told deputy he woke up in a daze and began to feel his rectum area hurting. Jimmy told deputy that he admitted himself into the hospital for the first time on Sunday, April 01, 2007. He advised that Golden Meadow Police Officer Mark Burgess brought him to the hospital initially. Jimmy told deputy he heard from other friends that Jamie Louviere had violated him sexually by pouring salt into his rectum, inserting beer bottles into his rectum, inserting the handle of a hair brush into his rectum, and supposed to have video taped the entire incident. Jimmy told deputy that Jamie Louviere supposedly confessed to her co-worker Wendy Neill about the incident.

On Tuesday, April 10, 2007 at approximately 10:00 a.m., Sergeant Todd Charlet and Detective Steven Pitts met with Jonathan McCartney (w/m dob: 9-18-80) at the Galliano Substation. McCartney told detectives that he and Jamie Louviere have a three-year-old daughter together. McCartney told detectives that he recorded Jamie Louviere from his cellular phone as to the events that took place with Blankenship. McCartney provided detectives with a copy of the micro cassette recording. McCartney told detectives that Jamie did not know she was being recorded. Detectives listened to the recording and heard the following: Officer Mark Burgess did bring him to the hospital. The hospital said that someone did shove something up his ass. Ma, his roommate Sammy who is a Maxican, and Daniel is a Maxican guy. I was barely putting it in there. I was going to ease my way, like I was rubbing some Vaseline around it and the dude came and like hit my hand and pushed it harder to his ass. I rubbed it in. The fucked up thing is that I only threw the brush on top of the roof. The wind could blow and have that bitch knocked down already. Annette and Simba came wake me up and asked me if it was true saying that when they woke up, Sammy and the other Mexican guy was all in the room saying, Man guess what we did last night. Detectives obtained an audio taped statement from Jonathan McCartney and obtained a copy of the micro cassette recording for evidence.

On Wadnesday April 11, 2007 at approximately 8:30 a.m., Sergeant Charlet arrived at the Sugar Bowl motel room 232 in Houma and made contact with Jimmy Blankenship. Jimmy signed a consent form for detective to obtain his medical records from Lady of the Sea hospital in Galliano. Jimmy told detective he was in extreme pain when he went to the hospital.

At approximately 1:00 p.m., Sergeant Charlet arrived at Lady of the Sea hospital and reported to medical records to obtain copies of Blankenship's records. Detective read over the records and found that Blankenship's chief complaint was rectal pain and alleged being assaulted rectally with multiple objects. The report indicates that there were no tears, scratches, or evidence of trauma to anal area. No bruises seen. No swelling seen. Fine white granuals (salt?) were found near the anal area. No evidence of External Rectal/Anal trauma or injury.

At approximately 2:40 p.m., Sergeant Todd Charlet met with Wendy Neill (w/f dob: 10-08-72) at the Galliano Substation. Neill told detective that she was a co-worker with Jamie Louviere at P.J.'s Fed Pond in Golden Meadow. Neill told detective that Jamie Louviere told her the following information inside of her

SENTENCE

Considering your plea of guilty to the charge of Second Degree Battery, I sentence you, JAMIE LOUVIERE, to pay a fine of \$2,0000.00 and court costs within One (1) year of sentencing. Payment shall be made to the Lafourche Parish Sheriff's Office. In default of payment the defendant shall be imprisoned within the Lafourche Parish Detention Center for a period of Six (6) months. The Court authorized partial payments for fine and costs.

The defendant shall be imprisoned at hard labor by the Department of Public Safety and Corrections for Five (5) years; with credit for time served in custody prior to the imposition of sentence.

Execution of the sentence at hard labor shall be suspended and the defendant is placed on supervised probation under the supervision of the Division of Probation and Parole for a period of Three (3) years with the following special conditions:

- You shall serve a term of 28 days without hard labor within the Lafourche Parish
 Detention Center with credit for time served.
- 2. You shall report to the Division of Probation and Parole within 48 hours of sentencing.
- You shall pay a monthly supervision fee of \$75.00 to the Department of Public Safety and Corrections.
- You shall pay a monthly fee of \$5.00 to the Louisiana Sexual Offender's Notification Board.
- 5. You shall report to the Probation Officer as directed.
- You shall permit the Probation Officer to visit at home or elsewhere and conduct searches
 and seizures without a search warrant. The Probation Officer may be assisted by any
 Municipal, Parish, State or Federal Law Enforcement Officer.
- You shall remain within the Jurisdiction of the Court and receive the permission of the Probation Officer before making any change in address or employment.
- 8. You shall submit to Medical, Psychiatric, Mental Health or Substance Abuse examination or treatment or both when deemed appropriate and ordered to do so by the Probation

Officer; and to pay all costs of examination and treatment. You shall be routinely subject to alcohol and drug testing by Probation Officer.

- 9. You shall refrain from criminal conduct.
- 10. You shall refrain from owning or possession firearms or other dangerous weapons.
- 11. You shall devote yourself to an approved employment or occupation.
- 12. You shall refrain from entering into or frequenting bars and lounges.
- 13. You shall refrain from the excessive use of alcohol and the illegal use of drugs.
- 14. You shall pay the sum of \$100 to the Louisiana Commission on Law Enforcement to be credited to the Drug Abuse Education and Treatment Fund November 15, 2009.

Your payments for fees shall be cocurrently with the payments of fees imposed in Docket Number 432508.

You are convicted of a crime of violence.

The Court does impose restrictions concerning diminution of sentence for good behavior (see C.Cr.P.ART.890.1).

You have two years from the date this conviction becomes final to apply for post conviction relief as provided in Article 930.8 of the La. Code of Criminal Procedure.

- 26. Refrain from entering into or frequenting bars and lounges.
- 27. Refrain from the excessive use of alcohol and the illegal use of drugs.
- 28. Pay the sum of \$100.00 to the Louisiana Commission on Law Enforcement to be credited to the Drug Abuse Education and Treatment Fund by November
- The defendant's probation shall commence immediately.
- 30. Subject agrees to abide by all special conditions of probation ordered by Judge Larose in court on April 18, 2008.

In accordance with Act 823 of the 2006 Regular Legislative Session, if a probationer has a monetary obligation, including, but not limited to, court costs, fines, costs of prosecution, and any other monetary costs associated with probation, a judge may extend the period of probation until the monetary obligation is paid.

Failure to comply with the foregoing conditions may cause your probation to be revoked. During the period of probation, you shall be subject to arrest at any time by the Probation & Parole Officer, either with or without a warrant, for the purpose of returning you to the Court for further disposition.
